## Evolution AIE | Highlights Annual report 2016

**Evelyne Schellekens** – General Secretary of AIE - gave an overview on the AIE activities and firstly reported on the Climate Package 'The Clean Energy for All Europeans' and in particular on the state-of-play of the review of the Energy Efficiency Directive **[EED]**, the Energy Performance of Buildings Directive **[EPBD]** and the Primary Energy Conversion Factor **[PEF]**.

AIE positions on the legislative proposals, common statements with other installers associations on inspection, renovation and e-mobility, alliances and joint declarations with stakeholders on the renovation rate, target ambitions and electrification, as well as a common explanatory note on why the PEF should be lower than the current 2.5 or proposed 2.0, illustrate the actions undertaken by AIE.


Other important topics such as the Smartness Indicator [SRI], Electric Vehicles/charging stations, RES (PV) and self-consumption, Lighting systems, Residential Electrical Safety [FEEDS group] were mentioned as other key issues for 2017-2018.

An important event for the electrical sector where **young talent and youth** is put in the spotlight, is the bi-yearly **Euroskills competition** for young electricians. As an associate member of Worldskills Europe, AIE is very active before, during and after the competition. Being a **platform for the education and training experts in the electrical sector,** AIE shares its expertise and knowledge. During the competition, the AIE intensively reports live through Blog, Facebook and Twitter.

As a conclusion of the joint Summit, AIE's message (equally transmitted at the 62<sup>nd</sup> annual Convention of Wholesalers) reflects the 2-days discussions and exchanges: 'Today the electrical industry offers us a wealth of new, intelligent and efficient technology and in addition, internet and the digitalization are pushing us to change the way we used to do business. Innovation and digital processes such as BIM (Building Information Modeling) will help that happening, and more than ever it will be important for installation companies to have neutral interfaces with correct, reliable and upto-date product data. We believe there is enough space for everybody to deploy energy efficient solutions and technologies in buildings.

In a strong, united and respectful value chain each one has a role to play: manufacturers produce, wholesalers distribute, installers install and this will bring benefits to all!'
